2.2 Work In-Progress Status, Brian Gallagher, LA City and Alice Roth, CD-4 Field Deputy

a) Trader Joe's Corner

Can't justify putting in a traffic signal because it is only 240-feet from one signal to the next. The City has a 300-foot minimum. Suggestion was made to move one of the traffic signal.

b) Stop sign requests

- **Huston/Forman** The City cannot install a stop-sign at the location because it does not meet City criteria.
- **On Camarillo between Lankershim/Tujunga** City is still looking at this location. The City will plot accident reports to see if there is a sufficient amount to make a recommendation.
- **Alley and Forman** (south of Riverside) regarding stop sign and parking issues. It was suggested that the alley between Forman and Clybourn (south of Riverside) be made a "one-way" alley going from East to West (Clybourn to Ledge is suggested).

c) MTA Grant Money

Unused Grant -\$5 million. City Staff looked at the Toluca Lake Elementary School and will create a Drop-Off zone on Cahuenga (curb cut) and create a pick up zone on Strohm. MTA money is approved to finance these projects.
 Final Design is expected in September 2007
 Construction expected to start June 2008
 Completion expected November 2008

d) Install Left-turn signs at Cahuenga and Camarillo; Riverside; and Moorpark

Poor visibility.
 Phase One 50-foot red curb as a remedy.
