2. *JAY ASKED HARRY FLYNN TO NOMINATE A REPRESENTATIVE FROM HIS AREA (WEST TOLUCA LAKE) FOR THE PUBLIC SAFETY COMMITTEE.*

3. *CRIME REPORT - ROB BENAVIDEZ COULD NOT ATTEND, BUT SENT JULY CRIME REPORTS. ONLY A FEW CAR BREAK-INS AND OUR AREA LOOKS GOOD LATELY.*

4. *NEIGHBORHOOD WATCH – JANICE EATON REPORTED THAT IT HAS BEEN RELATIVELY QUIET FOR THE MONTH. A VIDEO OF A MAN LOOKING IN APARTMENT WINDOWS WAS RECEIVED AND WILL BE SENT OUT. INFORMATION WAS SENT OUT REGARDING A MAN ATTEMPTING TO ACCESS A HOME AFTER EXITING FROM A CAB. WHEN CONFRONTED BY A NEIGHBOR HE LEFT THE AREA. POLICE WERE CALLED.*

5. *COYOTE ISSUE – A SPEAKER FROM THE CITY WILL BE AT THE GTLNC MEETING ON AUGUST 17 TO DISCUSS WHAT CAN BE DONE.*
