1. MEETING OPENING AND CALL TO ORDER - 7:05 PM

ROLL CALL WAS TAKEN.

AGENDA WAS REVIEWED.

MINUTES FROM SEPTEMBER 7, 2010 WERE APPROVED AS SUBMITTED.

- 2. ROB BENAVIDEZ REPORTED ON THE CRIME MAP FOR SEPTEMBER. OVERALL CRIME WAS UP FOR THE PERIOD AS WELL AS BTFV CRIMES. A HOT PROWL (HOME OCCUPIED) WAS ALSO REPORTED FOR THE FIRST WEEK IN OCTOBER. WINDOWS WERE OPEN AND NO ALARM WAS ACTIVATED. VALLEY VILLAGE HOMICIDE SUSPECT WITH REWARD POSTED IS STILL AT LARGE. ROB DISCUSSED WITH BETSY CEDER THE PROSTITUTION INCIDENTS ON STROHM AND WHAT COULD BE DONE. THERE WAS A DISCUSSION OF THE RELATIONSHIP BETWEEN THE TERMINATION OF THE LAPD RED LINE TASK FORCE AND THE INCREASE OF THE PROSTITUTION INCIDENTS IN THE AREA. ROB GAVE AN UPDATE ON THE PAPARAZZI. HE WARNED ABOUT MAIL COMING TO HOUSES IN SOMEONE'S ELSE'S NAME AND CAUTIONED THAT WE SHOULD NOT PRESUME IT IS MISADDRESSED AS THE ADDRESS MAY BE BEING USED FRAUDULENTLY. CATHY NAUGLE ASKED ABOUT VACANT HOMES, AND ROB REPORTED THAT THEY SHOULD BE REPORTED TO LAPD AS THERE ARE SCAMS USING CRAIGSLIST AND FRAUDULENT LEASES.**
- 3. JAY ASKED STEVE HAMPER TO CHECK WITH THE CHAMBER TO SEE IF THERE HAS BEEN NOTICE OF A CHANGE IN SPEED ON RIVERSIDE DUE TO THE REMOVAL OF THE SPEED LIMIT SIGNS. HE ALSO ASKED ABOUT GETTING A MERCHANT MEMBER FOR THE PUBLIC SAFETY COMMITTEE.**
