1. MEETING OPENING AND CALL TO ORDER - 7:25 PM

ROLL CALL WAS TAKEN.

AGENDA WAS REVIEWED.

MINUTES FROM OCTOBER 4, 2010, WERE APPROVED AS SUBMITTED. (AJALAT/DUBLIN)

** WE WERE UNABLE TO ENTER THE SCHEDULED MEETING LOCATION AT CD4. AFTER WAITING UNTIL 7:20 PM FOR ADDITIONAL PARTICIPANTS, THE MEETING WAS MOVED TO FRANK BANYAI'S RESIDENCE AT 4426 TALOFA AVENUE. TO ALERT LATECOMERS TO THE MOVE, A SIGN WAS POSTED AT CD4 ADVISING OF THE CHANGE OF LOCATION.

2. ROB BENAVIDEZ DID NOT ATTEND. JANICE EATON REPORTED ON THE NEIGHBORHOOD WATCH START UP MEETING ON SATURDAY, OCTOBER 30, FOR THE TOLUCA WOODS AREA. APPROXIMATELY 60 PEOPLE ATTENDED ALONG WITH ALICE ROTH. JANICE EATON AND FRANK BANYAI EXPLAINED HOW NEIGHBORHOOD WATCH WORKS FOR THE BENEFIT OF PETER GENERALES.
3. SOL AJALAT REPORTED THAT TRYING TO CROSS CAHUENGA AFTER THE TOLUCA LAKE BIKE RIDE WAS IMPOSSIBLE WHILE THERE WAS NO TRAFFIC ON LANKERSHIM.
4. FRANK BANYAI GAVE UPDATE ON THE TALOFA TRAFFIC SIGNAL. MAY BE COMPLETED BY JANUARY.
5. BETSY CEDER ASKED ABOUT LIGHTS ON STROHM AND RIVERSIDE AREA TO HELP WITH PROSTITUTION ISSUE. SHE WILL ALSO TALK TO NEIGHBORS AND ASK THEM TO CALL LAPD WHEN AN INCIDENT OCCURS AND SEND PHOTOS WHEN POSSIBLE.

6. **DISCUSSION WITH PETER GENERALES ON HOW THE BUSINESS AND RESIDENTIAL NEIGHBORHOOD WATCH WOULD WORK TOGETHER ALONG WITH THE BENEFITS OF SHARING INFORMATION. JANICE EATON WILL CHECK WITH STEVE HAMPAR ABOUT GETTING THE EMAIL ADDRESSES OF THOSE BUSINESSES WHO WANT TO JOIN THE NEIGHBORHOOD WATCH.**
