- JAY GOLDBERG REPORTED ON THE SUCCESS OF THE KIDS DAY EVENT SPONSORED BY THE SAN FERNANDO VALLEY COALITION ON GANGS. THE COMMITTEE REAFFIRMED THEIR APPROVAL FOR A \$500 DONATION TO THE EVENT.
- JAY GOLDBERG REPORTED THAT TAMAR GALATZAN WILL REPLACE TIM SAITO AS NEIGHBORHOOD PROSECUTOR. SHE IS WILLING TO ATTEND OUR EVENTS AND LOOKS FORWARD TO INTERACTING WITH THE COMMUNITY.
- JANICE EATON AND STEVE HAMPAR DISCUSSED THE NEXT NEIGHBORHOOD WATCH CAPTAIN'S MEETING. A TENTATIVE DATE WAS SET WITH ROB BENAVIDEZ FOR JANUARY 25, 2011. STEVE HAMPAR WILL CHECK FOR AVAILABILITY AT HONEY BAKED HAMS AND JAY GOLDBERG WILL REVIEW MONEY AVAILABLE IN THE BUDGET. JANICE EATON WILL CONTACT RYAN ALTOON REGARDING PUTTING THE WATCH CAPTAIN MAP ON THE WEBSITE.
- JAY GOLDBERG REVIEWED THE 2011 DATES FOR PUBLIC SAFETY MEETINGS. ALL WILL BE ON THE FIRST MONDAY OF THE MONTH WITH THE EXCEPTION OF JULY WHICH WILL BE HELD ON TUESDAY, JULY 5.

- 6. JAY GOLDBERG REPORTED ON A HATE MAIL LETTER MAILED TO NEIGHBORS IN THE FORMAN AREA. NO FURTHER DETAILS AT THIS TIME.**
- 7. ALLEN ST. ANN REPORTED A BTFV INCIDENT AT 4:30 AM ON DECEMBER 6 NEAR HIS HOME IN BILOXI AREA. POLICE WERE CALLED AND A GOOD DESCRIPTION OF SUSPECT AND VEHICLE WERE REPORTED. INCREASE IN VEHICLE BREAK-INS IN THAT AREA WAS DISCUSSED.**
- 8. ROB BENAVIDEZ REPORTED ON THE NOVEMBER CRIME MAP AND BILOXI AREA CRIME INCREASE. HE ALSO GAVE AN UPDATE ON THE APARTMENT BURGLARIES IN NOVEMBER ON MOORPARK WAY AND RIVERSIDE DRIVE AND THE SPEED MONITORING ON RIVERSIDE. THE PROSTITUTION INCIDENTS ARE A LOW PRIORITY AT THIS TIME AS IT IS A VICTIMLESS CRIME.**
