**3. Current Business**

a. Review and Approve GTLNC Environmental Affairs Committee Minutes

b. Review of prior year

**APPROVED 1 Sept 2020**

- Geoff expressed frustrated at being singled out by another meeting attendee for expressing his views; stresses that land doesn't vote, and the amount of land owned does not make one voice more important than another
- Hannah shares some of the committee's frustrations, particularly the concern that GTLNC isn't representing all voices in the neighborhood but rather actively has represented a small portion of the voices that can afford to put in more time to attend the meetings
- Katherine notes that we do hear from some underrepresented voices at EAC, but they tend to be told at the general meeting that their opinions don't count, and it's unlikely that EAC can make significant changes to that issue
- Kelly believes that is a function for outreach and an issue with education. Kelly has heard from some groups, like the HOA, that believe they represent a larger percentage of the population than they do because there isn't an awareness across Toluca Lake of the different stakeholders
- Katherine is concerned by the misinformation that we were unable to counter at the meetings due to the virtual meeting format which limited time and positioned our speaking as "opinion" rather than factual information
- Hannah asks the committee if we picked the right "fights"
- Geoff things there's value, whether motions pass or fail, in asking people to explain their positions on these issues

c. Planning & priorities for upcoming year

- Kelly suggests we think about how to communicate the facts since these tend to be very dense issues
- Hannah recommends bringing in people from the city or an experienced firm to present on these issues (waste reduction, mobility issues, recycling, etc) on why these are important to fight climate change, inequity, etc so that the board understands the why and the baseline facts
- Katherine notes that wealthier and whiter communities contribute more to climate change, but communities of color and less wealthy communities suffer more of the effects, and as one of those wealthier and whiter communities based on city-provided demographics, it's likely that we are some of those high-contributors
- Hannah would like to have someone talk about connection between mobility and racial justice as well as gender justice; will look into 2 people
- Katherine cautions against overloading on transportation
- Kelly would like a speaker about the urban tree canopy and the impact of their private property to the greater good in a neighborhood with limited public green space
- Jim brings up concerns about vacant lots with no trees, like the clearing of the lot at Riverside & Ledge where we lost trees, making it not just an eyesore but bad environmentally. Committee agrees this might be more for Planning and Land Use
- Geoff is interested in increasing housing density, but isn't certain EAC needs to work on that given the State is working intensely in the area. Does believe that trees are popular, and also recommends we speak to transportation concerns in a practical sense
- Hannah has stats that show 77% of TL are interested in improving mobility
- Geoff asks if education or mobilization will be more effective?
- Kelly notes we're in a very stressful time and the community is opposed to change in less uncertain times. Suggests bringing in partners through Chamber, etc to allow the community to enjoy the benefits of a "15 minute city" before we have the more difficult conversations about flashpoint issues like bike lanes
- Katherine feels that the previously planned 3-Mile Challenge would have been a good opportunity to incentivize people to get out of their vehicles, and there's an opportunity to revisit in the fall to partner with the Chamber to also incentivize people to patronize our local businesses
- Hannah saw a lot of businesses from the GTLNC/Chamber business survey that want to continue al fresco dining even after Covid is done. Other cities have taken parking spaces to use

for that outdoor dining, and there's advantage to getting people out of their cars so there's less need for parking in the area. How can we encourage people not to drive when they come to Riverside? Recommends as a project to discuss at September meeting.

- Katherine wants someone to present not just on waste reduction, but on conscious consumption because reduce comes first in "reduce, reuse, recycle" but most focus is on recycle
- Action item: think about ways to get people out of vehicles in the neighborhood, take a look at the "15-minute city" article
- Hannah encourages expanding membership

- Katherine recommends the committee is strategic about approaching contentious topics, concerned that votes for other motions have been impacted because there's some possibility there's uncertainty and distrust about our committee that comes from how more contentious motions have been presented

- Hannah cautions against being swayed by people voting on motions a particular way because of other motions they dislike, though if there is a personal distrust that needs to be addressed
- Katherine clarifies that the concern is that people may be uncertain about trusting us because they are hearing misinformation that isn't effectively countered
- The committee notes that sometimes facts don't win, like the way the Riverside bike lane became the issue when it wasn't even part of the motion
- Kelly reminds that semantics matter; arguments can be coopted easily so we need to have a way to, in the least amount of words, say "this is not xyz" and move on so that the argument doesn't get diverted

- Do we continue with CIS? How do we want to address contentious issues?

- Geoff recommends picking one thing we'll likely lose, but try to win the rest
- Katherine agrees it's great to identify issues that people are widely supportive of because that builds trust that allows us to have a baseline trust for when we bring more controversial issues; frontload those
- Kelly supports doing the no-brainers that will be easy to pass, but also make sure that we don't put excessive time into things we know may not pass
- Hannah wants to identify the "hills to die on" – issues that we feel very strongly about putting the time into fighting for
- Katherine has been struggling to get information on the CIS process since nothing that's been passed has been officially submitted as CIS; until we have a process in place to effectively submit them then our CIS are basically moot
- Hannah recently learned that when we pass a CIS, we get time at the City Council meeting to speak on it, and we should take advantage of that
- Jim believes that governmental affairs should be bringing information about City Council action to us; Also agrees with the plan to pick one big issue to fight for; Believes in committing to John Lewis's ten principals of being a good global citizen and recommends everyone give it a read as it's a good roadmap even for our tiny fights here

- wait and see how we proceed with tree planting initiative given we can't get together (trees are a win-win popular goal)
