- Reached out to North Hollywood Neighborhood Council b/c Alice Roth in CD4 office wants them to be involved; NoHo is concerned that the Pasadena BRT route

- may go down the median and destroy any work we do; exploring LADOT/Metro timeline
- c. Educational Speaker Series – previously discussed putting together speakers that could talk to the GTLNC general board meeting (short 5 min presentation) and direct them to larger presentation coming up on that topic from their group. However, exec committee feels the general meeting already runs long enough and would only OK a brief promotional 1-2 min presentation to direct people to other events; not a full 5-minute presentation

- Jim feels the speaker series may not be worth the effort because the time speaking at the general meeting is so limited
- Katherine recommends rethinking the plan – can take an approach that we just highlight virtual events coming up both at the meeting and through the newsletter
- Hannah expresses frustration that this concept of bringing people to educate at the meetings was a suggestion from the president, but now we cannot do it
- Hannah wonders if the newsletter will be effective at directing people; proposes instead to focus efforts on identifying city council activities that we can research and respond to with CIS (community impact statements) or letter similar to Plastic Parking Permits letter
- d. 15 Minute City Project
- Kelly brought to the EAC, so will wait to move forward until she can participate

7. New Business/Future Projects

- a. New Camarillo Bike Lane
- Committee is excited to see new bike lane on Camarillo; added safety for bikes without reducing traffic lanes; connects to Burbank bike lane
 - Let’s think about ways to promote the bike lane and that it can help connect people to our businesses

- given GTLNC budget has been reduced this year and the uncertainty of how much schools will be able to utilize a program like this, the EAC will let the group know that we’re putting this on hold until we have more clarity and that we invite them to reach back out in the spring
- f. Sidewalk Improvements
- Katherine interested in sidewalks connecting our business district to Cahuenga as well as some sidewalks on Cahuenga leading to Toluca Lake Elementary
 - Will inquire with Alice Roth in CD4 whether we should do a full board motion to request



- g. E-Waste Disposal
 - Robyn Allyn (GTLNC Sec.) brought idea to do an e-waste collection in Toluca Lake; would need to identify a company that's licensed to collect
 - Jim confirms the Glendale SAFE center for e-waste and hazardous household waste is open again
 - Given covid restrictions, we'll aim to direct people to existing city/county SAFE services rather than host drive in Toluca Lake right now
