Jonathan Gregory: *stated comments about business engagement. Homeless stabbing incident at Sarah St 1:30am on Jan 1st. What influences that Neighborhood council can have with law enforcement?*

Tess Taylor: *frequent mail crimes, contacting the inspector general*

Paige Cram Fakhraie: *Also having an issue. Trying to get mailboxes rekeyed.*

Tony Carey: *Covid testing at Universal City Walk, walk ups accepted which is free and you receive a PCR but you must pay for parking. Wants to have Covid info put in GTLNC notification board. Robyn will place in board.*

a. LAPD Report: SLO –Kurtis Delbar

Joining panel today LAPD Capt. Mohammadi.

Reported on stabbing from Sarah St., random in nature. Victim died. Dept only has 9100 officers currently so deployment is difficult. Covid and lack of graduating classes is the reason for the drop in numbers. 2021 had 9 homicides, 2020 had 11 homicides.

Paige Cram Fakhraie: *Asked for location of stabbing. 11000 block of Sarah and Vineland Place*

Tess Taylor: *reported on homeless and other incidents in WTL area.*

Capt Mohammadi & Officer Delbar: speaks about encampment laws.

Jay Goldberg: *states on history of PS committee. Goals were to get the committee active with 100 neighborhood watch captains. Harry Flynn was a leader in the Neighborhood Watch.*

Robyn Allyn: *offered to add more lighting*

Jonathan Gregory: Will LAPD visit Sarah location? Will LAPD shine their lights in that area? Where exactly did this incident happen? Can Neighborhood Council send out a CIS stating a position? How often are there police visits?

Capt Mohammadi: *Sarah Project in place, modeled to problem solve i.e. shrubbery etc. along with the community to solve this issue. Funding issue for a very large area is a problem.*

Shawn Besharaty: asks if he could be part of the Sarah Project.

AB 361 UPDATES Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned.

If members of the public are unable to provide comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.
