a. How to report a crime

Kurtis – Asked if anyone has any questions about how to report a crime? Tony asked about 911 vs non-emergency

Kurtis said 911 is a crime in progress, non-emergency would call 877-ASK-LAPD

Tony asked if there was timeframe for reporting.....Kurtis said there is no time limit but its important to report things as soon as possible.

Tony asked what's the difference between incident report vs crime report.

Kurtis said incident report is a where something happens but there really isn't a tracking of it. The history log is needed to be kept by the victim. There isn't a paper trail at LAPD. There are paper trails for crime reports.

Greg asked about a few personal situations that happen to him. Kurtis said that if he gets a card from LAPD that means that it was an incident report.

Kurtis said that a burglary report will require you to come down to the station.

Tony asked if you can ask for a supervisor if the LAPD isn't writing a crime report. Kurtis said yes.

Tess said she had a disturbing incident that happened and couldn't file an incident report at the station.

Kurtis said 7am to 11pm are the station hours.

Kurtis said the last 2 break-ins seem to be linked but there doesn't seem to be anything since then happen.

Party house should be non-emergency lines.

Jason asked about Turo – Kurtis said that he is working with Todd Gillman to help deal with this. Jim asked if these cars need commercial registration with the DMV. Kurtis said yes.

Tess mentioned Vineland Pl. is starting to have RV parking issues.

Greg asked how many days you can park a car. Kurtis said it's 72 hours from when the officer sees it.
